FOR MAATSUYKER ISLAND

Maatsuyker Island is recognised locally, nationally and internationally as having unique heritage, natural and Aboriginal values where:

- historic values and evidence of Aboriginal heritage are well conserved and protected by heritage listing;
- natural values are healthy and free of impacts from invasive species;
- these values are clearly reflected in a Maatsuyker Island Group Management Statement and the Tasmanian Wilderness World Heritage Management Plan and
- volunteer programs and limited public visitation opportunities are well-managed and support conservation of the island's values.

FOR THE FRIENDS OF MAATSUYKER ISLAND (FOMI), THAT WE:

- Have strong, enthusiastic, diverse and well-informed members and supporters.
- Acknowledge the interest and role of Aboriginal Tasmanians as past, present and future custodians of the island and encourage engagement with Tasmanian Aboriginal people and communities.
- Have a mutually respectful, professional relationship with the land manager of the island: Tasmania Parks and Wildlife Service (PWS).
- Undertake volunteer work and activities that meet or exceed the workplace health and safety legislation requirements, policies and guidelines.
- Conduct or facilitate useful, respected, relevant research and information sharing projects.
- Are financially sustainable such that our resources enable us to realise our vision.
- Have a long-term commitment to the island and engage in succession planning activities.

- The skills, expertise, sustained effort and substantial input contributed by FOMI's supporter and volunteer base over a significant time period are recognised by PWS.

WHAT HAVE WE ACHIEVED?

Over the last ten years FOMI has:

- Contributed at least \$100,000 per annum of volunteer in-kind and money to achieve the following in partnership with PWS:
 - o extensive and necessary work to weatherproof and restore the lighthouse tower and fittings;
 - o annual weed control, reduced the areas of four target weeds (Blackberry, *Veronica* (prev. *Hebe*) *elliptica*, Montbretia and Californian Thistle) by approximately 70 ha;
 - completed substantial work to bring the island's historic quarters up to a functional standard, including the internal fitting out of houses;
 - o annual monitoring (since 2013) of the island's short-tailed shearwater breeding population;
 - o documented most of the historic objects located on the island.
- Maintained a vibrant, well-functioning Wildcare Inc. group that has a high level of commitment to the island and its conservation.
- Maintained a professional and mutually beneficial relationship with the PWS.
- Worked with the PWS to support the PWS volunteer caretakers and artists in residence on the island.
- Conducted 13 day-trips to the island by boat to support the PWS volunteer caretaker program and to promote community understanding of the island's importance.
- Published a booklet and other education materials about Maatsuyker Island.
- Mounted four displays and exhibitions (10 Days on the Island, Maritime Museum, Rosny School House and Rosny Library) and consistently took part in events such as the Australian Wooden Boat Festival and Seafarers Festival, as well as conducted talks and held information sharing (The Royal Society of Tasmania, the Lighthouse Conference, Landcare Tasmania Conference, Wildcare Gathering and U3A Island Arks Symposium) regarding the unique values of Maatsuyker Island.

FOMI Achievements 2018-2021

- Lighthouse restoration especially rust and stain removal, steel priming and interior paint removal (latter approach now adopted by other lightstation repair projects).
- Weed eradication program implemented Fulcrum GIS mapping and tracking of weed locations; rope work extended and consolidated works; significant decrease in remaining target weeds.
- Consolidated annual shearwater monitoring program and received increasing recognition for its importance.
- Building achievements restored floors in all houses. Found and installed matching Q2 bedroom door.
- Historic objects restored a whim trolley and acquired and reinstalled kerosene tanks in the lighthouse.
- Inclusion of PWS volunteer caretakers in working bee programs.
- Strengthened and diversified FOMI committee and membership and working bee participation.
- · Strengthened PWS engagement and partnership.
- Increased social media profile, taking advantage of Wildcare marketing opportunities and development of high-quality merchandise products.
- Attracted consistent, annual grant and philanthropic funding including ongoing support and recognition from the Pennicott Foundation of the weed control and shearwater monitoring programs.
