The lightstation, which was manned by lightkeepers for over 70 years, is now part of the Tasman National Park. FoTI – Wildcare Inc works in partnership with the Parks and Wildlife Service (PWS) to maintain and enhance the cultural and natural heritage values of Tasman Island.
